

### A Brief Introduction to Blue Cross of Hyderabad

Blue Cross of Hyderabad was founded by Nagarjuna and Amala Akkineni in 1992 with an animal rescue service. It was registered as a Society in Jan 1993 taking up animal welfare activities with the help of animal lovers like Vasanthi and Krishna Vadi, Dr.Lakshmi & Dr.Ramana Rao, Mrs.Jayashree Sarathy, Indira Venkatachalam and Dr.Viyjaya Kumari. All the services of Blue Cross were set up intending directly to benefit stray (or wild) animals and birds of all species from the street, homeless, abused, sick or dying, in need of help.

The guiding principle of Blue Cross: "All animals are sentient beings. And whether they are domestic or wild, used in science, sport, the production of food, entertainment or any other field; they deserve freedom from cruelty."

Blue Cross is funded by donations, grants and sponsorships. It has no income and makes no profit. All office bearers are honorary and devote their time on an honorary basis.

### The services for animals are:

Animal Rescue, treatment and shelter for injured and sick animals from the street. Prevention of Cruelty to animals, Sterilization & Vaccination of stray dogs and cats (ABC/AR), Adoption of puppies, kittens and abandoned pets, rehabilitation of rescued wildlife. We also have a Mobile Veterinary Clinic for working Equines funded by the Brooke Hospital for Animals, U.K.

Besides these services the organization runs the Blue Cross Junior Club movement for children. The members liazon with Government departments to improve animal welfare in the twin cities. Members inspect and supervise Laboratories conducting animal experimentation. Blue Cross coordinates and celebrates animal related events and provides information and articles to the press and media for spreading awareness on animal related issues. Blue Cross has no publicity budget. All the activities are a result of someone committed making the time and effort. The Blue Cross of Hydreabad is living proof that Humanity is capable of much more-compassion and responsibility towards all living creatures.

"We believe that all animals are entitled to freedom from fear, pain and suffering - whether in the name of science or sport, fashion or food, exhibition or service. If they are domestic, not to be tortured or abandoned in the city streets, by a country road, or in a cruel and inhumane pound.

And finally, the right at the end, the right to a decent death - not (whether they are endangered or not) by a club, by a trap, by harpoon, cruel poison or mass extermination chamber. And because we are the protectors of the earth and all it's life forms, we have only one creed - to speak for those who cannot, in the name of Compassion."

### From the Secretary

Dear Members and Supporters,

The responsibility of Animal welfare and running the Blue Cross is always a privilege! I am extremely grateful to all the wonderful people who came forward to make the Blue Cross and animal welfare possible. These people have braved the suffering, the heat and the scarcity of funds and have willingly stayed on to make a difference. I particularly thank my Mother, who retired and returned from England to Hyderabad to help run our shelter for animals.

Despite the trials and tribulations, Blue Cross of Hyderabad, this past year has helped 18,922 animals and birds. Of these 3253 animals were rescued, 5194 street dogs sterilised and 7096 vaccinated against rabies, 40 wildlife were rescued and rehabilitated, 1522 pet animals given Veterinary care, 84 animals were saved from incidents of cruelty and 600 working equines assisted with veterinary care, water troughs and shade shelters. Of these numbers 555 animals died and 284 euthanised due to severe injuries and illness. We do not believe in putting down an animal unless treatment fails to relieve extreme suffering.

On behalf of the animals I extend a grateful thanks to Smt. Maneka Gandhi, Hon.Minister for Social Justice & Empowerment, the Animal Welfare Board of India, the Commissioner & Additional Commissioner, Municipal Corporation of Hyderabad, Mr.Bhupal Reddy, Director, Urban Forestry, the Brooke Hospital for Animals, U.K., the R.S.P.C.A., U.K., our Patron and sponsors, our Architect and Builder and to all of you, without who's support none of this would have been possible.

# Activity report for the year April 2000 to March 2001

### 1. Blue Cross Ambulance and Animal Rescue Service:

3253 Sick, abused and injured birds and animals were rescued from the streets and treated at the Blue Cross Animal Welfare Center.

### 2. Shelter & Veterinary Clinic.

3253 Rescued Animals were given shelter and veterinary care during the past year. 1522 pet animals were given Veterinary care. The shelter and clinic is supported by donations of money and kind from the community. A new puppy enclosure was constructed sponsored by Mr.A.G.S.Reddy. A new large animal shelter and quarantine kennel facility was built with financial aid from the Ministry for Social Justice & Empowerment. Both buildings are functional and have improved our facilities considerably.

# 3. ABC/AR: Animal Birth Control & Anti Rabies Immunization for community dogs.

The Blue Cross believes that the sterilization and vaccination of community dogs is the best humane and scientific solution to the dog population problem. This is because the catch and kill method of dog control has not worked in the past.

By sterilizing and vaccinating community animals they do not populate, are protected from rabies and will not allow new dogs into the area. The killing of strays only allows new animals to invade the city carrying overpopulation and rabies in with them This year we were able to sterilize 5194 stray dogs and vaccinate 7096 against rabies. We were asked to start a second unit at the Municipal Dog Pound. The second unit has been functioning since Jan 2001.

# 4. Mobile Veterinary Services for Equines:

The mobile Veterinary service for Equines funded by the Brooke Hospitals for Animals (U.K.) has extended veterinary care to approximately 600 working equines registered with us, in an area of 50 kms radius. They work 6 days a week, visiting 14 locations. 6568 Cases were treated this year, and 55 horses and donkeys were brought for more intensive treatment and rest to our shelter. A shade shelter was built at Yadagirigutta, water troughs were provided at all areas, 2 temporary shelters were built in the old city, 62 sets of new saddlery were distributed at subsidised rates and a farriery course was conducted for local farriers on horse shoe ing and general horse care.

443 Pet animals including puppies, kittens, full grown dogs and cats, were given for adoption to responsible owners. The Blue Cross ensures all animals are vaccinated, sterilized and dewormed before adoption. Every quarter an advertizement is placed in the local newspapers advertizing homes for full grown abandoned pets, homeless puppies and kittens. The advertizements are sponsored by Life members.

# 6. Prevention of Cruelty, Wildlife rescue and rehabilitation:

The Blue Cross investigates complaints regarding cruelty. This year 11 cases of Cruelty to animals were registered. The Blue Cross has been responsible for the confiscation of 4 performing Sloth bears from their owners and subsequently their rehabilitation at Conservatories and zoos. The Blue Cross Policy that believes "Wildlife belong in the wild". Even zoos are not considered suitable for wildlife except for those injured, captively bred or unable to survive in the wild. 79 Cattle were rescued from illegal road transportation, crammed as many as 32 and 35 animals per lorry. Legally only 6 full grown cattle are permitted.

7. Eight Veterinary Camps for the under privileged were conducted where 880 animals were treated including cows, buffaloes and dogs.

### 8. Blue Cross Junior Club movement for children:

His Excellency, Dr C Rangarajan, the Governor of A.P. inaugurated the Blue Cross Junior Club movement for children at a function conducted by the Forum for better Hyderabad. A Club kit was prepared sponsored by Nutrine Confectionaries. The clubs are meant for children below the age of 16 to help learn about animal welfare in a focused and helpful way. 4 Clubs were inaugurated this year. To start

a club, please contact the Blue Cross for a Junior Club folder and read through the guidelines. A dedicated and enthusiastic adult is necessary to guide the club activities.

The Blue Cross collected Rs 25,000/- from the Top Dog Carnival Pet show which was donated to the Animal Wlefare Board of India to help the animals affected by the earthquake in Gujrat. The Animal Welfare Board of India has spent over rupees thirty lakhs for relief work at Gujrat.

10. Construction of Shelter and Administration Building:

Construction of our animal welfare centre continues. We received financial aid form the Ministry for Social Justice and Empowerment and Mr.A.G.S.Reddy towards construction. We have therefore been able to complete construction of our cattle shed, cattery, puppy kennels and quarantine for sick animals. Next year we hope to complete a bear shelter for temporary holding of bears. The Director Urban Forestry, Mr.Bhupal Reddy, and Mr.R.K.Rao very kindly arranged the planting of 35 trees at our shelter last monsoon, to ensure a better environment for the animals.

### 11. The Animal Welfare Fortnight Celebrations:

The Fortnight activities were jointly organised by Dr.Lakshmi, Mr.R.K.Rao, Satish & Maya Aripirala and Vasanthi & Krishna Vadi. They did a fabulous job in conducting the following activities:

- 1. The fortnight was inaugurated with an Awareness March from The Charminar to Bhagyanagar Goushala at Imliban, where a health camp for rescued cattle was held. 50 People from animal welfare participated in the march flagged off by the AC Police, Charminar, to mark the fortnight celebrations open. 460 Cows and Calves were vaccinated against Foot & Mouth Disease and tagged at Imliban health camp.
- 2. Health camps for bullocks in the market area was also conducted where awareness material about overloading laws were distributed.
- 3. Anti Rabies Vaccination camps for dogs were conducted along with distribution of awareness material in Urdu and Telugu about the Animal Birth Control and Anti Rabies (ABC/AR) programme. In the old city area of Mogulpura, Balamrai 420 dogs were vaccinated.
- 4. People for Animals, Hyderabad conducted 10 Raids on Illegal wildlife markets, "No- overloading Day"at Ranigunj Steel Market educating bullock owners

about the PCA Act and Transportation Rules. Inspections of 19 Temples were conducted, preventing animal sacrifice 12 Raids on illegal transportation of cattle for slaughter were made. The injured cattle were nursed back to health at Blue Cross.

5. An Animal welfare meeting was conducted by the Commissioner of Police attended by all NGO's and all the DCP of the 4 zones in Hyderabad. PFA distributed the important points of the PCA Act in the form of laminated posters for all Police Stations.

6. Blue Cross Junior Clubs were inaugurated in 4

7. The fortnight celebrations ended in a cheerful note with the Top dog Carnival (Pet Show) for pet dogs, which focused mainly on pet owner relationships and encouraged Indian dogs as pets. Sponsored by Effem India, Blue Cross collected Rs 25,000/- from the event which was donated to the Animal Welfare Board of India, to help the animals affected by the earthquake in Gujrat.



### Other Activities and Events Conducted:



An essay competition for children from Urdu and Telugu medium schools and cash prizes were given to the winners for the 'Young Animal Activist Writers Award'.

World Animal Day was conducted on October 4th with a walk on Tank Bund representing all 5 Animal

Welfare Organizations of the twin cities. The march ended at Lumbini Park where the group repeated the Compassionate Charter for Animals, pledging to work for animal welfare.

Blue Cross of Hydreabad Annual General Body Meeting was conducted on the 21st of January 2001 at Blue Cross, commemorating our 8th Anniversary.
