

INTRODUCTION

From the Founder – Amala Akkineni

Dear friends,

On the occasion of our 15th annual report, I am overwhelmed with the number of wonderful people who came forward last year to help Blue Cross animal welfare work from varied backgrounds, to pitch in with time, money, effort and compassion.

This year has been rather turbulent. During the panic with dog bites, the

Human Rights Commission Chairman demanded we give an explanation regarding what we are doing to reduce stray animal population. We proved the efficacy of our programme by sharing with him that not one dog in the areas we work had bitten anyone, nor carried Rabies! Slum dwellers in hundreds wanted to show up at the hearing in our support, for the safety we have created in their communities through the sterilization and vaccination of street dogs! We restrained them as it may have turned into a stampede! Smt. Maneka Gandhi's presence was much appreciated.

It is my duty to bring you abreast with what took place this past year at Blue Cross of Hyderabad. Through our 9 services for animal welfare, we have been able to help 34,176 animals and birds. The large numbers do not necessarily mean better work, as we are forced to stretch ourselves with over crowding that leads to cross infections, etc.

At the Asia for Animal Conference at Chennai we were humbled with the tremendous efforts and professionalism shown in other parts of Asia. Inspired by AFA I request you to help the animals on your street by keeping them healthy and friendly. Bringing them into our shelter need only be the last resort. For the coming year, we are initiating a mobile Veterinary team that will visit certain city areas bringing timely, planned Veterinary care for stray and community animals. We are recruiting and training teams to take up the CNVR for stray dogs: which means catching, neutering, vaccinating and releasing the dogs of a locality on the same day. We have decided to shelve the newsletter and post all updates for viewing on our website: www.bluecrosshyd.in so

I take this opportunity to acknowledge each one of our Veterinarians, staff, rescue drivers, committee members & volunteers for their efforts. I thank our donors and sponsors for their contributions of precious funds without which nothing is possible. Thank you all so very much!

The Ambulance and Rescue Service

Our Rescue service got an immense boost with the donation of a new Maruti Van by Mr. Amarnath of Tirumala Music Center. The new van has less vibration and is environmentally less polluting compared to our other ambulances. This along with ideas from EMRI services of additional washable mattresses for the floors to cushion the rescued animals, good ventilation and a silent engine ensure that the animals are comfortable and calm. We are very grateful for the overwhelming generosity of Mr. Amarnath.

Our Animal Ambulances rescued 7,284 animals during 2006-07. Many of these were hit and run accident cases on the widened roads. In October alone 24 road accidents were treated out of 41 ambulance rescues.

CNVR - Catch, neuter, vaccinate and release on the same day

We invited and introduced a team from "Animal Help Foundation" Ahmedabad headed by Mr. Rahul Seghal to the Municipal Commissioner. They moved in and took care of the most difficult areas in the old city where the spate of dog bites had taken place. We then agreed upon training a team in the new technique to enable us to take up more operations and move into the problem areas. The CNVR is breakthrough as far as mobility and speed is concerned. By catching and releasing the dog on the same day without taking it into a pound, all incidences of cross infection are prevented. Besides this, there is no need for infrastructure and the local people get involved and sensitized. We are grateful to Rahul and Animal Help Foundation for their help.

Prevention of Cruelty to Animals Efforts

The total neglect and cruelty cases were 291, with 11 animals being confiscated from their owners. Many cases were unvaccinated pets, pets untreated for various problems, pets running at risk on the roads, un-neutered and multiplying the homeless dog numbers, biting people, etc.

Counseling was given in cases of genuine ignorance, and warnings to careless, irresponsible owners. We support the difficult cases and help rehome the animals with caring people. Thanks to our member Swamy S.B. Das's involvement, we can now zero in to ensure investigation,

Veterinary Hospital & Doctor's Report

The Veterinary Clinic and Facility at Blue Cross is run by Dr. Peter Nolosco who joined us in July 2006. Dr. Peter has soon become a center life line of our work for the animals. We are very happy to have his services. Here follows his brief report:

The Emergency Care Unit was set up in Jan 2007 with the aim of ensuring Veterinary care to Rescues, In Patient and Out Patient animals. It consists of B Type Oxygen cylinder with Face Mask to deliver oxygen to emergency patients, Ambu Resuscitator, various sizes of Endotracheal tubes and all emergency medicines to deal with any type of emergency case. So far 25 dogs rescued in a very critical condition have survived because of the new Emergency Care Unit.

The other units established to upgrade our facilities were:

Physiotherapy Unit

This consists of Short Wave Diathermy Unit, Ultrasound Massage Unit, Infra red Unit to deal with various forms of inflammation contusion, spinal compression, spondylitis and as alternate form of pain relieving mechanism and to improve the function of defective locomotor system.

Laboratory

Equipped to carry out Tests like Differential Count, Tests for various Blood Parasites, Vaginal Cytology etc.

X-Ray Unit

On an average 10 X-Rays of large & small animals are taken per day, which are used as a diagnostic aid to procedures.

Orthopaedic Cases

As the City traffic and road accidents have increased over the last year, we get a lot of fracture cases. 91 orthopaedic surgeries were performed successfully in dogs and cats. Several of these animals are housed permanently at Blue Cross Shelter due to unavoidable amputations.

Other Important Cases

We had 29 Cases in dogs with mammary and other skin tumours which were surgically removed and later chemotherapy was given and the animals were released to their locality. Follow up visits found them to be doing well. Other cases like hernias, bladder calculi, severely damaged eyeball also required surgery. 1 dog with complete cut of nasal-cavity was repaired to get back its cosmetic appearance by nasal reconstruction surgery.



Animal Welfare Efforts for Community Safety

Adoption programme

596 families and individuals adopted animals during the year. Of these 54 were adult dogs, 327 pups, 17 cats, 121 kittens, 22 cows, 18 buffaloes, 30 rabbits, and 7 pigeons.

Adoptions slowed down in March, probably due to examinations, summer vacations etc.

Shelter for the sick, injured, abused and needy

Approximately 9500 animals passed through our Shelter for various reasons. The Shelter is the core of our work as it provides a place to bring in homeless animals that need Veterinary care and prepare them for adoption or birth control measures. Constant efforts were made to upgrade the shelter facilities, repair and maintain the heavy wear and tear of the large numbers of animals, that really detest to be confined and do everything they can to break out! With the inauguration of our new Cat Shelter the cats look happy and healthy in the outdoor environment and a strict vaccination plan has kept it disease free. Mr. and Mrs. AGS Reddy are to thank for their generosity and commitment to support these homeless animals.

In March 07, a number of safe friendly community dogs were given sanctuary from public ire due to a spate of dog bites. We often have 650 or more community dogs in the Shelter for various reasons and are on a war footing for population control.

Animal Birth Control & Anti Rabies Vaccinations

7 Rabies cases were picked up including 5 dogs, 1 cow and 1 goat. All cases were reported by the public and did not cause panic.

2525 male street dogs and 2626 female street dogs were sterilized and vaccinated. Every breeding pair of dogs can give raise to 3000 in their life time. So considering this ratio we have humanely reduced approximately 26,26,000 street dogs from roaming our streets in the future.




Snakes are tortured and killed at festivals!




Adoption Drive for Indian Puppies

ACHIEVEMENTS OF THE BROOKE & BLUE CROSS OF HYDERABAD PARTNERSHIP

Mobile Equine Welfare Programme

Committed to sustainable equine welfare, the efforts of the Mobile Equine Care Unit have been manyfold. They ventured into new areas and explored new approaches to carry out interventions to ensure equine welfare. These equines: horses, donkeys and mules belong to the poorest of poor communities in A.P. and are bread winners for these families. Some efforts worked really well and other efforts are yet to show results. On the whole it was a great year and we learnt a lot. We are grateful to the Brooke Hospital for Animals now known as "The Brooke" and the Delhi team of C.E.O. Mr. Murthy, and A.F.O. Col. Pundir for their valuable support and guidance. Here is a brief report:

Animals treated by the Mobile Veterinary Unit were 175 Horses + 840 Ponies + 6592 Donkeys.

Number of equine emergency cases treated were 105.

10 severely injured animals were admitted to the Blue Cross animal shelter for recovery.

Details regarding the efforts:

This year we made efforts to involve support from the community in all activities. We upgraded our understanding and methods to educate animal owners to ensure basic standards of care for the animals. Our team consists of Dr. A. Yadav, Veterinary Officer (VO), Prem the driver cum Paravet, Farrier cum Paravet Anjaiah, and Community Facilitator (CF) Venkateshwarulu.

Community Facilitators efforts: The Community Facilitator (CF) Mr. Venkateshwarulu joined us in the month of August 2006 and required a few months of training and introduction to the animal owners. He started Community Facilitation full swing in December 2006 with the following:

Building a rapport with animal owners who were not interacting earlier.

- Increasing owner's awareness on standards of care through group meetings has and motivating attitudinal change.
- Intensive Equine Care Camps using educational material, individual interactions, home visits and field visits.

The animal owner's participation in meetings, discussions etc., is difficult due to their long working hours, lack of coordination and confidence among themselves about the new efforts. Most tonga owners in Kurnool district earn below poverty line, they have no education and have never been involved in any kind of group activity. In some cases they are alcoholic, or in heavy debt. In other cases they have been cheated by local political rowdy sheeters who have exploited their ignorance. In this hostile and hapless ground our CF strives to make a difference.

Twenty five group meetings were organized with animal owners. However the biggest difficulty faced was that the Tonga owners earlier ran a Tonga association that had failed. Hence they have no confidence or faith among themselves and have less interest to participate in meetings. They also face heavy work for long hours and many financial problems. The BHA/BCH team tries to motivate the owners continuously and in three areas horse owners came forward to form groups. Unfortunately in two groups the owners took off with the money, but one group has been successful.

The Veterinary Officer's (VO) efforts:

The role of our VO is of veterinarian, team manager and facilitator. Through group meetings with the owners our Vet tried to bridge welfare gaps and make them realize that without owners taking responsibility Veterinary treatment alone was futile. This effort resulted in a marked improvement of animal health failing only where hired handlers cared for the animals. This awareness among the owners needs constant improvement. The best results have been noted at Kodumur, Veldurthy in Kurnool etc.

The team identified local health providing services, people with vested interest like quacks and

had useful interactions to reduce harmful practices. The team developed rapport between animal owners and stake holders (Farriers, Saddler and local health providers). This facilitated animal owners and stake holders (Farriers, Saddler and local health providers). This facilitated better and timely repairs, shoeing etc. They educated animal owners on symptoms and disease identification.

The team focused on training owners in proper handling of animals, loading issues and maintenance. The VO motivated animal owners to understand the do's and don'ts clearly, so that they could use local resources safely. The team treats animals in the premises of Government Veterinary Hospitals which helps build local treatment network and confidence in animal owners. Veterinary Hospitals which helps build local treatment network and confidence in animal owners. Govt. staff are actively involved with the team and ensure follow up treatment. Local Veterinary dispensaries have now become confident to treat equines and owners are confident to visit them. Even the interaction between the veterinary assistant and animal owners has become cordial.

Apart from this VO organized a workshop on Equine Management with veterinary Assistants, Private Practitioners (Local quacks) and animal owners. He plans to concentrate on sharing of responsibility with Government institutions and organizing more training and interaction on Veterinary measures to support local institutions in operation areas where he found willingness.

The team organized demonstration for local farriers and animal owners to improve their skills. They focused on highlighting malpractices and educated animal owners on preventive care, basic management skills like water, feeding and saddlary maintenance etc. Through planned efforts the Saddler supplied saddle equipment for Aleru tonga animal owners on installment basis. A telephonic helpline for emergencies became operational and very well used.

Efforts for Donkeys working at Brick Kilns:

Brick Kiln donkeys are used for carrying bricks from kiln to the loading areas. Totally six brick kilns are in function with 106 donkeys and 21 horses in two places (Ravirala & Kongara) Rangareddy District, and four places in (Solakpalli-3 & Kodkanchi) Medak District. This year the animals started the season in good health as compared to last year where they were found emaciated after the

rest period. The team constantly focuses on motivating owners to ensure welfare measures, shade shelters, fresh drinking water and balanced feed .

The CF and VO built rapport with brick kiln owners, visiting them frequently and holding discussions. We noted a number of improvements: The brick kiln owners demonstrated their responsibilities this year by constructing shade shelter walls and water troughs. In partnership with our team they plan to construct the roof to ease animal suffering in the heat and rain. They have allotted care takers for the welfare of donkeys, feeding and grazing the animals, dressing wounds and resting the injured or sick animals from work. One brick kiln owner arranged woolen belts to line the donkey's spine. This worked as a good preventive measure to reduce pack wounds and relieve weight.

The Community Facilitator focused on training the donkey handlers, constantly reminding them of the animals needs. Much of the wounds have reduced and the owners call for help if the animals get sick. On the whole it has been very promising.

Kurnool Operational Areas:

BHA/BCH unit extended its services to the other districts as in areas of Mahaboob Nagar, Kurnool and in few areas of Anantpur district. These district tonga owners belong to the poorest of poor communities. Tonga ponies are the bread winners for their families. They have no accessibility of veterinary treatment from Govt. Veterinary Hospitals therefore they depend on the services of local quacks. Some times there are fatalities due to lack of proper treatment. When the team started operations in Kurnool the equines had severe saddle wounds and injuries due to improper shoeing. The team concentrated on improving the condition of the animals with the quality veterinary treatment as well as bringing an attitudinal and behavior change among animal owners through community facilitation. Year to year the team implements their innovative strategies for the welfare of equines with noticeable improvement and success.

Euthanasia is a part of our work. If any animal is struggling with severe lameness or injury and in great pain, no longer fit for work, we humanely put it down. Compensation is given to the owner as contribution towards the cost of purchasing another animal.

Intensive Equine Care Campaigns: Twice in the year our team organized the IEC campaigns in Nanded district areas, Maharashtra state.

Training programme of Government Veterinary Assistants:

The VO organized a one day training programme on Equine Management for government Veterinary Assistants, Private Practitioners and animal owners at the Govt. Veterinary Polyclinic, Kurnool. Around 21 veterinary assistants and 13 animal owners participated in the programme. Dr. Venkata Ramanarao Joint Director of Kurnool and Dr. Jammaluddin Assistant director cum



TOT of Government veterinary department of Kurnool helped conduct the programme and Dr. Thanmal gave her valuable inputs. The Kurnool district government department provided excellent support in the training programme and have since actively taken up equine care.

The school talks started in May 2006 along with Cova (Confederation of Voluntary Organisations) where Heera Rupani spoke about animal welfare and the environment at six different summer camps in the old city covering children in groups of fifty to hundred. The talks were planned with the help of COVA at schools where children are not exposed to the concepts of kindness to animals or in areas where incidents of cruelty to animals are high. Report on Olive Ridley Turtle Protection in Orissa

The Cause:

Along the coast of Orissa lies the last nesting ground of the Olive Ridley turtle. The Gahirmata Marine Sanctuary being the area for breeding and the Mahanadi and Devi river mouths being the main nesting grounds where the females come ashore to lay their eggs. During this time hundreds of adult turtles are caught and killed in the nets of fishing trawlers. The others come ashore to have their nests destroyed. The eggs hatch after 45 days leaving nests vulnerable to both human and animal predators. The young making their way to the sea are further at threat and only one in thousand make it to adulthood!

Marine protection is still unknown in India, less in Orissa where schools and access to education is still a privilege. While 75% of Earth's oxygen comes from Algae beneath the oceans, protecting the oceans is unheard of, and even less about protecting marine life.


Blue Cross of Hyderabad, inspired by Greenpeace, took on a project to support the Olive Ridley turtle. The issues were: (1) Mass deaths due to fishing trawlers (2) Mass destruction of the nests due to predators (dogs in particular) (3) Local apathy and lack of awareness (4) Lack of education and quality environment in these areas

The Plan:

In October 2006 we budgeted for the project. In November Tata Indicom came forward with a proposal to conduct a charity auction of cartoons offering the proceeds to the Blue Cross. Our project found the resources! In December we located a local group at Devi River mouth called Green Life Rural Association. We invited the Secretary Mr. Sovakar Behera to sign an MOU for a project and train with us. Between Jan19 and 21, Dr. Peter Nolosco and Swamy S.B. Das were in Orissa to launch the project.

Here is what we achieved at Devi Area:

1. Awareness regarding the role of the Olive Ridley and need for it's protection, through meetings with fishermen. Meetings were held on a monthly basis with local fishing groups. The fishermen and their families took on the responsibility to protect the turtles and their nests.

 Veterinary surgeons were trained with support from the Government of Orissa. Launched during January 2006, it took 4 months for 200 females stray dogs in the Devi area to be during January 2006, it took 4 months for 200 females stray dogs in the Devi area to be sterilized and vaccinated against Rabies. This indicates a significant reduction of stray population and thereby destruction of the turtle nests.
- 4. Interaction with Government Authorities to step up the efforts: The Director of Veterinary Services and the Principal Secretary Fisheries were very supportive in all efforts and ensured all departments participated in the mandatory ban on trawlers during the turtle breeding season. Further efforts for a state wide stray animal control programme were discussed.
- For environment enrichment tree plantation was taken up in these areas during monsoon. 801 fisher families planted trees around their homes. In all 2403 fruit trees including mango, lemon and coconut trees were planted.
- Due to scarcity of water, 4 hand pumps were provided for drinking water to 4 villages where the fishermen had taken on nest patrol besides switching to finer nets where the turtle does not get caught or trapped.
- 7. Patrolling of the nests during the nesting season was also taken on to prevent mass destruction of the nests.

In all it was successful and we learnt the joys of saving turtles and marine protection. This year the Arribada (Mass nesting) did not happen as it had done last year. The issues of India's environment and wildlife are vast scanning social-economic-political limitations. Yet with a firm and focused goal there is much one can do. Together we can do more! We are grateful for the involvement and commitment of Green Life Rural Association to ensure this project is successfully implemented. Your donations will ensure the project continues.

REDUCE GLOBAL WARMING! "REVIVE NATURE THROUGH TREE PLANTATION"

We initiated a project called "Revive Nature" for Tree planting efforts in the monsoon of 2006 through Nagarjuna Fans Association. The Fans included men and women from various walks of life all interested to take on reviving nature to ensure a better and healthier environment for both humans and animals. Taking inspiration from African Nobel Laureate Wangari Mathai, who says "If you tell a mother to plant a fruit tree for one day she can feed her children the fruit, then she will do it". The tree during it's life (50 years) can give 5.3 lakh rupees worth of oxygen, 10.5 lakh rupees worth of pollution control & cooling equivalent to 5 air conditioners running day and night, 5.3 lakh rupees worth of fruit, fodder and seeds, and 6.4 lakh rupees worth soil fertility & erosion control besides sending moisture into the atmosphere for rains, giving home to birds, animals and insects. 
